The Southern Delaware School of the Arts prohibits acts of harassment or bullying. SDSA has determined that a safe and civil environment in our school is necessary for students to learn and achieve high academic standards. Harassment or bullying, like other disruptive or violent behaviors, is conduct that disrupts both a student’s ability to learn and our school’s ability to educate its students in a safe environment. Demonstration of appropriate behavior, treating others with civility and respect, and refusing to tolerate harassment or bullying is expected of administrators, faculty, staff, and volunteers to provide positive examples for student behavior.

“Harassment or bullying” is any gesture or written, verbal, graphic, or physical act (including electronically transmitted acts-i.e. internet, cell phone, or wireless communication device) that is reasonably perceived as being motivated either by an actual or perceived characteristics such as race, color, religion, ancestry, national origin, gender, sexual orientation, gender identity and expression: or a mental, physical, or sensory disability or impairment; or by any other distinguishing characteristics. Such behavior is considered harassment or bullying whether it takes place on or off school property, online, or at any school-sponsored function.

Supervisory System in Non-Classroom

Teachers and staff monitor hallways and monitor student behavior during bus duty, recess and lunch duty. Students are required to sign-out of the classroom when needing to use the restroom. All students are escorted to and from the cafeteria and arts classes.

Reporting Requirements

All teachers are required to respond to student reports of bullying by taking action via the school-wide bully report (pink paper in front office) by notifying the administration.

Investigative Procedures

All student complaints will be reported to the counselor and/or administration. Students will be interviewed. Parents will be notified.

Range of Consequences

The Southern Delaware School of the Arts subscribes to the “Successful Learning for All” discipline policy. These steps may not be sequential based on the offense.

- Referral to Counselor with parent contact.
- Parent conference with teachers/administration/student · Office referral-may include verbal reprimand or in/out of school suspension and behavior contract
- Loss of monthly incentive
- Lunch or after school detention

Notification of Caregiver-all caregivers will be notified (of the victim and the accused).

Procedures for Communication

Each quarter, the Assistant Principal will update staff on any substantiated bully reports. The students’ information will be held confidential. Each month, an incentive is held to support good behavior. Parents are an integral part of the home-school relationship and are contacted immediately. The following programs will be implemented throughout the school year in an attempt to continue SDSA’s Bully

Prevention Program

1st -3rd Grades- The Six Pillars of Character- This is a program that is used to explore the six essential character virtues. This Character Education program will help the students to recognize what is right, care about what is right, and to do what is right. The program incorporates song, humor, thinking, talking, discussion and writing on the subjects of Trustworthiness, Respect, Responsibility, Fairness, Caring, and Citizenship.

4th Grade - The students in this program are mentoring 4 year old students in a “Buddy” type program. The students are paired together and work on academics and the development of life skills.

6th -7th -8th Grade- Delaware Attorney General Cyber /Internet Safety Program- This is a program run by the state Attorney General to help student become aware of cyber stalkers and improper/unsafe computer-cyber communications.

K-8th Grade- Classroom Visits- Various counseling topics as needed.
